The committee is authorized to invite and receive suggestions from members across all Zones regarding the proposed amendments to the **Bye-Laws**.

The tenure of the committee shall be two months, covering the period from **August to September**, within this stipulated period, the committee shall examine all suggestions, prepare a comprehensive report, and submit its recommendations to the Central Secretariat.

The Central Secretariat will thoroughly review the committee's recommendations. Thereafter, the proposed amendments, along with the Secretariat's recommendations, shall be placed in the next **E.C. meeting or General Council** for its consideration and approval. Any suggestions for Amendment Bye-Laws, should sent in written.
